SUBJECT: Letter of Guarantee for the Use of Liberchem Products in the Food Environment

To whom it may concern,

The Government of Canada has removed the requirement to register non-food chemicals used in food establishments. In the absence of specific Canadian regulations, **Liberchem** continues to apply the requirements previously established by the Canadian Food Inspection Agency (CFIA). The requirements of the European positive list are also considered to ensure that the products listed in Appendix 1 are compatible for use in a food environment.

We would like to confirm our commitment and ensure the proper use of **Liberchem** products in food establishments.

Liberchem undertakes to provide, upon request of regulatory authorities, all required documentation related to composition and manufacturing to ensure that these products are safe and fit for use as intended.

Liberchem undertakes to comply with these rules in the event of changes to the composition or labels of these products. If changes resulted in a non-compliant product, customers would be notified promptly, and the product would be removed from the list.

In addition, unless otherwise specified, the use of chemicals on potential food contact surfaces must follow the dosage limits specified in the label directions, followed by an appropriate rinse with tap water.
